The Program Fee is non-itemized. Included in the fee are round-trip travel from select cities as determined by the Overseas office, field trips, instruction, fees, room and board, and supplemental health insurance. <u>Not</u> included are passport and visa expenses, photographs, books, immunizations, and incidentals.

Once you are registered for your Overseas Study Program, the Tuition and Program Fee will be charged to your student account. At that point, your account will be pulled into Student and Departmental Account Services' regular schedule of statements.

The fall 2016 deadline to settle your student account is: August 11, 2016. The spring 2017 deadline to settle your student account is December 15, 2016. Thereafter, monthly statements will be generated if, for one reason or another, your account is carrying a balance due to the school.
