## Update on work accomplished in September

 Paris Program approved:The French Studies program and the Office of Overseas and Off Campus Programs are opening a new language-immersion program in Paris for either semester or year-long study. The first group of students may be attending as early as next fall. This is not an additional offering but a replacement for the discontinued Nancy program. Along with location, our French-immersion programs are differentiated by subjects: Strasbourg, with the EU parliament, emphasizes politics and economics; Senegal has a SOAN bent; and Paris will be most suitable for Arts \& Humanities students.

From the accreditation standards of the Northwest Commission on Colleges and Universities:

## Undergraduate Programs

2.C. 10 The institution demonstrates that the General Education components of its baccalaureate degree programs (if offered) and transfer associate degree programs (if offered) have identifiable and assessable learning outcomes that are stated in relation to the institution's mission and learning outcomes for those programs.
