The Total Fee for Off-Campus Study Programs is broken down as follows:

- > \$24,314 Tuition
- ➤ \$3,364 Room/Housing
- > \$2,684 Board/Meals
- > \$750 Administrative Fee

The Program Fee is non-itemized. Included in the fee are field trips, instruction, partner institution fees, room and board, and supplemental health insurance. <u>Not</u> included are airfare, passport and visa expenses, photographs, books, immunizations, and incidentals.

Withdrawal of Participant:

In the event the group membership of a student is terminated by the Participant before departure, the following schedule of fees will apply: a) \$300 if termination happens three months or more before group departure (the non-refundable deposit); \$3,000 if termination happens less than three months before departure (includes non-refundable deposit).

In the event Participant voluntarily withdraws from the program after departure for the program site, the following fees and charges will apply: a) if the withdrawal is during the first month of the program the participant will be responsible for one-half (50%) of the comprehensive fee; and b) if the withdrawal is after the first month of the program the participant will be responsible for the entire (100%) of the comprehensive fee. The College reserves the right to add any fees incurred by Participant to Participant's student account, and to refuse registration, provision of transcripts and issuance of degrees until all fees are paid in full.

^{*}Note: The first payment of \$300.00 is a non-refundable deposit to be made within 30 days from receipt of your acceptance letter or this document. If you have already paid the \$300 deposit, we thank you for your payment.

^{**}Payment is due in full by above deadlines unless semester costs are being made through the monthly payment plan with Tuition Management Systems.

Once you are registered for your Overseas Study Program, the Tuition and Program Fee will be charged to your student account. At that point, your account will be pulled into Student and Departmental Account Services' regular schedule of statements.

The fall 2017 deadline to settle your student account is: August 10, 2017. The spring 2018 deadline to settle your student account is December 14, 2017. Thereafter, monthly statements will be generated if, for one reason or another, your account is carrying a balance due to the school.
