1 **Be It Enacted by the Senate of the Associated Students of Lewis & Clark here**
2 **assembled that:**

3 **Section 1.** Insert into the Constitution the attached grammar changes.

4 **Section 2.** Insert into Article II, Section 4, Subpoint b, subsection ii, the following:

5 2. Shall hold two office hours a week in the ASLC Senate office.

6 **Section 3.** Amend Article II, Section 5, Subpoint d, subsection iii, section 1, to the
7 following:

8 The replacement of the SAA Liaison shall be appointed within the Student Alumni
9 Association.

10 **Section 4.** Amend Article II, Section 5, Subpoint f, subsection iii, section 1, to the
11 following:

12 The replacement of the CAB Liaison shall be appointed from within the Campus
13 Activities Board.

14 **Section 5.** This bill will come into effect immediately.

3 **Section 1.** Strike Article 2, Section 3, Subsection b., Point ii:

4 **Section 2.** The Cabinet shall not approve expenditures, including emergency
5 expenditures, exceeding four hundred dollars (\$400.00)

6 **Section 3.** Amend Article 2, Section 3, Subsection b., Point iii, so that it now is
7 Point ii.

8 **Section 4.** This bill will come into effect immediately.

7 to Section 13.

8 **Section 3.** Insert into Article II, Section 2, Subpoint d, Subsection ii, the following,
9 7. Shall have the option to appoint an administrative assistant to support the work
10 of the Community Relations Committee, subject to confirmation by the Senate.

11 **Section 4.** Renumber Section 7 of Article II, Section 2, Subpoint d, Subsection ii to
12 Section 8.

1 **Be It Enacted by the Senate of the Associated Students of Lewis & Clark here**
2 **assembled that:**

3 **Section 1.** Amend Article III, Section 1, Subpoint G of the Student Organization
4 Committee Bylaws to the following:

5 Students and student groups may pay dues to on-campus as well as non-College-
6 affiliated organizations, but student groups may not require dues for membership
7 within the student group. Members that contribute dues to an organization may not
8 receive preferential treatment for doing so.

9 **Section 2.** This bill will come into effect immediately.

5 **Section 2.** Renumber the subpoints 2-9 of Article II, Section 2, Subpoint f,

6 Subsection ii as subpoints 3-10.

7 **Section 3.** Insert into Article II, Section 2, Subpoint g, Subsection ii, the following,

8 2. Shall serve as a voting member of the Cabinet.

9 **Section 4.** Renumber the subpoints 2-8 of Article II, Section 2, Subpoint g,

10 Subsection ii as subpoints 3-9.

11 **Section 5.** Amend Article II, Section I, point c to state the following,

12 c. The aforementioned elected officers shall compose the Cabinet.

2 **assembled that:**

3 **Section 1.** Amend Article II, Section 2, subpoint g, subpoint ii, subpoint 3 subpoint
4 a of the ASLC Constitution to the following:

5 Shall chair PRA Boards.

6 **Section 2.** Amend Article II, Section 2, subpoint g, subpoint ii, subpoint 3 subpoint
7 b of the ASLC Constitution to the following:

8 Shall appoint one (1) Associate Justice to chair PRA Boards, with a two-thirds
9 (2/3) approval of the Senate.

10 **Section 3.** Amend Article II, Section 2, subpoint g, subpoint ii, subpoint 6 of the
11 ASLC Constitution to the following:

12 Shall administer sanction(s) when respondents are found responsible for Code of
13 Conduct violations by his or her PRA board in consultation with the Associate
14 Justice and board advisor.

15 **Section 4.** Amend Article II, Section 2, subpoint g, subpoint ii, subpoint 7 of the
16 ASLC Constitution to the following:

17 The Chief Justice shall convene a Constitutional Review Board that includes the
18 Associate Justice to resolve constitutional disputes.

19 **Section 5.** Amend Article II, Section 2, subpoint g, subpoint iii, subpoint 1 of the
20 ASLC Constitution to the following:

22 shall immediately convene the PRA to preside over the election of a new Chief
23 Justice

24 **Section 6.** Amend Article II, Section 2, subpoint g, subpoint iii, subpoint 1,
25 subpoint a of the ASLC Constitution to the following:

26 The voting members of the PRA from among its members or the presiding
27 Associate Justices shall elect the replacement Chief Justice.

28 **Section 7.** Amend Article IV, Section 1, subpoint b, of the ASLC Constitution to
29 the following:

30 One (1) Associate Justice

31 **Section 8.** Strike Article IV, Section 1, subpoint g, of the ASLC Constitution

32 **Section 9.** Amend Article II Section 1 Subsection e of the Peer Review Authority
33 Bylaws to the following:

34 The Chief Justice must also nominate PRA members and one Associate Justice for
35 approval of the Senate

36 **Section 10.** Amend Article II Section 1 Subsection f and h of the Peer Review
37 Authority Bylaws to the following :

38 “Associate Justices” shall now read “Associate Justice”

1 **Be It Enacted by the Senate of the Associated Students of Lewis & Clark here**
2 **assembled that:**

3 **Section 1.** Amend Article II, Section 2, subpoint g, subpoint ii, subpoint 7,
4 subpoint a of the ASLC Constitution to the following:

5 The Chief Justice shall appoint one (1) standing member of the Peer Review
6 Authority and one (1) standing member of the College Honor Board and one (1)
7 additional member from the College Honor Board or the Peer Review Authority to
8 serve on the Constitutional Review Board.

9 **Section 2.** This bill will come into effect May 9, 2011.
