

Conditions of Early Decision Admission

Your admission to Lewis & Clark is contingent upon satisfactory completion of all coursework for the current academic year at your current level of performance.

Fulfilling the Early Decision Agreement

Per the Common Application Early Decision Agreement you signed when you applied to Lewis & Clark College, you must promptly withdraw any applications you've submitted to other colleges and universities and make no additional applications to any other institution in any country.

Nonrefundable Deposit

A nonrefundable deposit of \$500 is required from all students who intend to enroll at Lewis & Clark College. This deposit is applied to your student account. **The postmark deadline for this deposit and the enclosed Now It's Your Turn Form is 11:59 p.m. Pacific time on Wednesday, January 15, 2020.** The Now It's Your Turn Form may be submitted online at go.lclark.edu/admitted.

Students must provide evidence of health insurance that meets minimum criteria established by the college, or pay for enrollment in the student health insurance program (\$1,469.50 per semester for 2019–20). Visit go.lclark.edu/insurance/comparability for more information.

All entering students are charged a one-time \$300 New Student Orientation fee. This fee is reflected on the fall bill. The NSO fee is waived for federal Pell grant recipients.

Financial Assistance

All admitted students have been considered for merit-based scholarships. If you are being offered a merit-based scholarship, it will be included in your financial aid award. Merit-based scholarship offers are final.

Students who filed the Free Application for Federal Student Aid (FAFSA) and the College Board's CSS/Financial Aid Profile by our priority filing date of November 1, 2019, have also been considered for need-based aid.

Financial aid funds cannot be disbursed to your student account until we receive an official final high school transcript showing date of graduation. If you will not graduate from high school, we must receive your GED or other state-recognized high school equivalency before your financial aid will be disbursed.

Credit for Prior Coursework and/or Examinations

To have college coursework taken while in high school evaluated for possible transfer credit, please provide an official transcript from the college granting credit for the course.

To receive credit for Advanced Placement (AP) and International Baccalaureate (IB) examination results, please send an official report directly to the Office of the Registrar (MSC 108). See the online catalog for specific department policies.

Final Transcript and Verified Test Scores

You must send an official copy of your final high school transcript showing date of graduation to the Office of Admissions by July 1. If you have not already done so as part of the application process, you must also submit a **verified** record of your SAT or ACT scores. Scores are considered verified if sent directly by the testing agency, included on your official high school transcript, or sent directly by your high school counselor. You are exempt from having to provide verified test scores if you applied for admission via the Test-Optional Portfolio Path.

Verification of High School Diploma

The Office of Admissions will confirm that all your transcripts are issued by a high school with a CEEB code. If a transcript is issued by a school lacking a CEEB code, the Office of Admissions will investigate to confirm the school is recognized by an appropriate state department of education or home school association. The Office of Admissions may request a copy of your diploma at any point in the admission process to verify enrollment and graduation.
