PROGRAM FEE PAYMENT SCHEDULE FOR YEAR OF STUDY IN MUNICH PROGRAM ACADEMIC YEAR 2019-2020

FEE SCHEDULE:

***Note:** The first payment of \$300.00 is a non-refundable deposit to be made within 30 days from receipt of your acceptance letter **or** this document. The \$300 deposit is applied toward your first semester Year of Study in Munich Program costs.

The Total Fee for Year of Study in Munich Program is broken down as follows:

- \$34,946 Tuition
- \$8,736 Program Fee*
- \$74 Health and Wellness Fee**

* Included in the fee are room/housing, residence permit, group excursions, semester subway tickets (evenings only), and supplemental health insurance. Not included are board/meals, airfare, passport expenses, primary insurance coverage, photographs, books, immunizations, and incidentals.

**The Health & Wellness Fee supports the operations of Wellness Services staff in delivering pre-program orientation services, as well as in providing health-related consultation regarding participant health needs. All students in the College of Arts and Sciences pay a mandatory fee of \$37 per semester.

Withdrawal of Participant:

In the event that a student withdraws from a Lewis & Clark Overseas Program, or is dismissed from the program, the following fees will apply:

If withdrawal occurs three months or more before the beginning of the semester (based on the Lewis & Clark academic calendar) the participant will be responsible for the \$300 non-refundable deposit.

If withdrawal occurs less than three months before the beginning of the semester (based on the Lewis & Clark academic calendar) the participant will be responsible for paying a penalty of \$3,000 (includes non-refundable deposit).

If withdrawal occurs at, or after, the beginning of the semester (based on the Lewis & Clark academic calendar) tuition and program fees will be prorated on a per-day basis, up to the 60-percent point in the semester. After the 60-percent point in the semester, the charges for tuition and program fees are not adjusted.

The College reserves the right to add any fees incurred by Participant to Participant's student account, and to refuse registration, provision of transcripts and issuance of degrees until all fees are paid in full.

Once you are registered for your Year of Study in Munich Program, the Tuition and Program Fee will be charged to your student account. At that point, your account will be pulled into Student and Departmental Account Services' regular schedule of statements.

The Fall 2019 deadline to settle your student account will be August 8, 2019. The Spring 2020 deadline to settle your student account will be December 12, 2019. Thereafter, monthly statements will be generated if, for one reason or another, your account is carrying a balance due to the school.
