Senate Bill Number FA18 SB003 A Bill to Amend the CSRC Bylaws

Be it enacted by the Senate of the Associated Students of Lewis & Clark here assembled that:

Section 1: Amend Article II, section 1, subsection d to read:

i. Shall be responsible for the selection of the Social Media Coordinator; Collins View Neighborhood Association Liaison; Community Service Facilitator; and Pios for Pios Coordinator

Section 2: Eliminate Article II, section 1, subsection e, clause i

Section 3: Amend Article II, section 2 to read:

- a. Shall be approved by the CSRC Coordinator by the conclusion of the first committee Meeting.
- b. Shall oversee public and social media as well as assist in website maintenance and the promotion of ASLC activities. c. Shall serve as a voting member of the CSRC
- i. Shall have one (1) vote within the CSRC

Section 4: Amend Article II, section 3 to read:

- a. Shall be approved by the CSRC Coordinator by the conclusion of the first committee Meeting.
- b. Shall be responsible for attending Collins View Association meetings and reporting to the CSRC and maintain relationships between the ASLC and the greater Portland area. c. Shall serve as a voting member of the CSRC
- i. Shall have one (1) vote within the CSRC

Section 5: Amend Article II, section 4 to read:

- a. Shall be approved by the CSRC Coordinator by the conclusion of the first committee Meeting.
- b. Shall be responsible for overseeing the Pios for Pios program by disseminating information

about the program, finding volunteers, and collecting donations through organizing tabling events throughout the semester. c. Shall serve as a voting member of the CSRC

i. Shall have one (1) vote within the CSRC

Section 4: Add Article II, section 5 to read:

- 5. Community Service Facilitator
- a. Shall be approved by the CSRC Coordinator by the conclusion of the first committee Meeting. b. Shall be responsible for partnering with relevant campus and community partners to plan and implement at least one (1) community service opportunity during the year. It shall be advertised as an "LC Day of Service."
- i. Shall have one (1) vote within the CSRC

Section 5: Amend Article II, section 5 subsection a to read:

a. Shall be at least six (6) members of the CAS Student Body, including at least two (2) ASLC Senators, Social Media Facilitator, the Collins View Liaison, Community Service Facilitator, and Pios for Pios Facilitator

Section 6: Amend Article II, section 5 subsection a to read:

f. Removal of Committee Members

i. Voting members of CSRC may be removed from the CSRC by a two-thirds (2/3) vote of the committee or by a two-thirds (2/3) majority of the ASLC Senate. ii. Members may be removed via voting due to failure to complete assigned tasks as listed in this bylaw or assigned by the committee or failure to attend committee meetings without notice to the CSRC Coordinator

Section 7: Re-number all relevant sections in Article II to be in numerical accord with these changes.

Section 8: Amend Article III, section 2 to read: 2. The CSRC shall ensure that service opportunities are occurring and available on campus, and ensure students can learn about and participate in them. The Community Service Facilitator and CSRC shall work in conjunction with appropriate campus and community members to coordinate a service activity at least once a year, to be known as the "LC Day of Service." CSRC shall work in conjunction with appropriate campus and community members to coordinate a service activity at least once a year, to be known as the "LC Day of Service."

Section 9: Amend Article III, section 4 to read: 4. The CSRC shall lead all fundraising duties and events related to Pios for Pios and seek assistance from the ASLC President when necessary.

Section 10: Amend Article III, section 5 to read: 5. The CSRC Coordinator is in charge of the ASLC Student Storage Subsidy for low-income students (particularly Pell Grant eligible and would be Pell Grant-eligible students)

a. The storage subsidy would be allocated to students after an application process b. The final decision to allocate the subsidy will be made by the CSRC Committee according to voting

mechanisms established by these bylaws c. A report on the allocations will be presented to the ASLC Senate and a record will be kept

by the CSRC on these allocations.

Section 11: Amend Article IV to read: 1. The CSRC Coordinator may apply for a budget from the Student Organizations Committee during the yearly allocation process. 2. The budget may be used to carry out assigned duties or assumed duties of the committees. This shall include money for the following items:

a. New York Times Readership Program b. ASLC Outreach c. Pios for Pios Outreach d. Community Service Initiatives e. Student Storage Subsidy f. Student Forums 3. The proposed budget allocation must be approved by a 2/3 majority vote of committee members before it is to be submitted the Student Organizations Coordinator.

Section 12: Amend Article V, section 1 to read: 1. The CSRC shall, in conjunction with the Auditor, be responsible for the maintenance of the ASLC website.

i. The CSRC Coordinator and Auditor shall maintain a record of effective outreach and advertising techniques. Techniques shall be updated as necessary per the recommendation of the CSRC or a consensus by the CAS Student Body via a survey conducted the the ASLC Auditory.

Section 13: Move Article V to become subsection 6 of Article III.

Section 14: This bill shall take effect immediately.
