A Bill to Amend the Constitution

Be it enacted by the Senate of the Associated Students of Lewis & Clark here assembled that:

Section 1: Amend Article III, Section 1, Subsection a to read:

- a. Shall include the following Executive Officers: President, Vice President, Treasurer, SAAB Chair, SOC Coordinator, CSRC Coordinator, the EIJC Chair, and the Auditor.

Section 2: Amend Article III, Section 3, Subsection f to read:

- f. Shall, in conjunction with the CSRC and the Auditor, oversee the ASLC website

Section 3: Amend Article III, Section 7, Subsection c to read:

- c. Shall, in conjunction with the Vice President and the Auditor, oversee the ASLC website

Section 4: Amend Article III, Section 9, Subsection c to read:

- c. Shall, in conjunction with the CSRC Coordinator and the Vice President, oversee the ASLC website

Section 5: Add Article III, Section 9, Subsection g to read:

- g. Shall be responsible for the creation and distribution of all meeting minutes and audio recordings in accordance with the Constitution.

Section 6: Delete Article III, Section 10 and renumber sections 11-16 accordingly

Section 7: Amend Article III, Section 14, Subsection a to read:

- a. Shall include the following Executive Officers: President, Vice President, Treasurer, SAAB Chair, SOC Coordinator, CSRC Coordinator, the EIJC Chair, and the Auditor.


Section 8: Amend Article V, Section 5, Subsection a, clause i to read:

- i. The Director of Elections, in accordance with the Chief Justice and the Auditor, may enact suitable punishment, including, but not limited to disqualification, as necessary.

b. The Vice President, the Auditor, and the CSRC shall be responsible for maintaining the ASLC and Senate websites up-to-date.

Section 10: Amend Article VI, Section 3, Subsection b, clause iii to read:

iii. Audio recordings of Senate meetings must be made available to the public upon request to the Auditor within two (2) days of the request.

Section 11: Amend Article VI, Section 3, Subsection b, clause v to read:

v. Meeting minutes of the Cabinet must be made available to the public upon request to the Auditor within one (1) week of the request.

Section 12: Amend Article VI, Section 3, Subsection b, clause vii to read:

vii. Audio recordings of Cabinet meetings may be made available to the public upon request to the Auditor within two (2) days if majority approval in the Cabinet is reached.

Section 12: Delete Article VII, Section 6, Subsection j and renumber subsections k-r accordingly

Section 13: Add Article III, Section 2, subsection h to read:

h. Shall coordinate ASLC appointed student representatives on appropriate college governance standing committees, institutional committees, and college *ad hoc* committees


Section 14: Add Article III, Section 3, subsection g to read:

g. Shall be responsible for recording, tracking, and enforcing the attendance policy of the Senate and Cabinet

Section 15: This bill shall take effect immediately.
