Q about student perception of issues

Do we think that students feel gender-based violence is a problem on campus

A- Nicole: It is a problem everywhere, specifically, sexual assault victims

feel they have no support/ blamed even by the Title IX coordinator

A- Ben: students are vocally supportive of sexual assault survivors but the actual logistics are kinda murky, not much tangible help on campus

A- FSU: past two years have made effort to survey students and get an idea, out of that concerns for the response policy was brought up as well as the effectiveness of prevention methods (PSI sexual health and consent). think about it, for incoming students, various meetings have expressed issues with the programs and implementation

DSU: Seems like sexual assault victims are pushed to leave campus

Q- so people talk about gender-based violence on campus

FSU- pockets of invested students but that does not seem to be the majority Some people say that that doesn't happen

Ariel: school is hesitant to be outwardly vocal. Tried to write about Title IX issues in athletics and was basically harassed by the faculty involved with those sports

Jack: if you don't come in contact with it personally or through friends, you don't hear about it

Q- places where violence happens more frequently?

Alden: the perception that certain communities have a more toxic culture and higher incident rate. School very fractured by community life

FSU- First years have warnings about certain groups to stay away from. That's as specific as we can be right now (in Senate). These groups are

Q - perception of campus safety programs?

Ariel: has had really good experiences with campus safety

Not something that is difficult to call upon and doesn't seem to be called very frequently

Q- process around title IX. Is it fair?

Alex: not many people know about the process of title IX and it is quickly forgotten about by the time PSI is over

Q- what have you found the best way to reach a lot of students?

Helen: we just did a survey on this. Word of mouth was number 1. Number 2 was the bark. Then posters and stuff like that. Word of mouth seems to be the best

Alex: tabling with food and snacks

Any final questions?

Helen: are you working with PSI?

A- yes but not til next year

The grant to get this position was tough to get to the fact that LC went though that effort showed good initiative for the faculty.

SP 19. Nicole's bill to amend Senate bylaws (read in full by Nicole)

Was going to form a group to work on it but everyone had a strong opinion so she wanted to keep amendments and conversation to the meeting

Alex: last time there were concerns on the lack of a definition of the term 'direct impact'. We could require a part of all resolutions to include an aspect within them about how they directly affect the student body. Add 'sponsors of resolutions must include language addressing how legislation relates to the LC student body'. something along those lines. The resolutions we have done have been valuable but should include a side section addressing its application to student body so.

Nicole: resolutions should show a way and difference for the student body

Ben: if we include something about actual actions happening as a result of the bill. Prevents a resolution that is all talk

Nicole: a bill is an action though. Even including a list of resources or a social media infographic would be much better than a sole bill

Alex: mandating action is problematic. Has no definition and could be too vague and a definition could limit and restrict the term. Yes, they should include action but it shouldn't be a requirement, it should be a group answer and inclusion on bills presented to the Senate

Hannah: this is important but it needs to be made though training and intention rather than bylaws or legislative rules

FSU: could we write elements of this conversation into the Resolution template

Nicole: how can we get resolutions to hold power and encourage action?

Alden: resolutions are single time things. The right to notice a lack of action is viable but it is not necessarily the norm

Hannah: this is why we should put it in the training. Went to the training this year and could see it being more valuable as a facet of that

Alex: FSU suggestion of putting this in the template is good too. Both that and the training would be successful

Nicole: so make it more of a recommendation rather than a change in the bylaws/legislation?

Alex: ya.

Hannah: in training, it could be a conversation and a history of the reason for the new recommendations for resolutions could be explained

Violet: the recent statement resolutions have confused students about what the ASLC does. Past resolutions have been largely about things on campus and this year it has gone of that track. Maybe not a precondition to include action but turn it into a thing that is directed toward campus/student body

Alex: also we need to keep in mind that not all resolutions need to be emailed to the whole student body. We can limit which get sent to the student body and direct things more to the appropriate audience. The bill in its current form is too restrictive but the goal is something we need to figure out and accomplish

Ben: we want to send future senators in the right direction

Alex: we could create a google doc to make a collaborative effort to come up with a solution outside of Senate

Jack: we should decide what we want to do with the bill at this moment. But it is something better worked on outside of this meeting

Nicole: we will find a way to work on this together. But for now, withdraw the bill

Next item

Alex's bill to amend bylaws and delete article 3 section 3. Delete the bylaws section that says funded bylaws are ok. Constitution says that they are not ok so there is an inconsistency there. It doesn't mean anything in the bylaws because the constitution is supreme and the funded resolutions have been deleted from there. Doesn't change anything, it just makes it consistent

Jack: reservation is that is it better to erase this or change the place money comes from for funded resolutions.

Tom: 4300 account was leftover money from clubs and student fees. SOC does not allocate money in the regular sense it is used instead for new clubs
