- Nicole: This is to clean up Constitution. It's unclear about who
 manages the website which falls under the CSRC, so adds them
 throughout the proper sections

- Alex: cleans up Finance Committee bylaws, which already passed
 within the committee. It deletes the weird clause about removing
 Senators that's not in other bylaws. It deletes when it was last
 updated since it's redundant and changes when funds are available.

Michelle: Associate Justice can be appointed within the year.

J. SB016

- Roland: The language was really unclear, executive was changed to Cabinet, added a timeline, clarifying language from pluralality to abstaining or approving. If more abstaining, then send out another application with wider parameters
- Quentin: We talked about changing it from 3 to 2 weeks so there's more time to possibly change requirements if necessary. I was wondering if we could amend that
- 3. Roland: Friendly amendment
- 4. Alex: Does this apply to appointed positions also?
- 5. Roland: Yes
- 6. *Motion to vote*
 - a) All: aye

- II. Continuation of Discussion
 - A. Jacob: I wanted to begin by saying we think the focus should be on addressing systemic racism at this school. There are other incidences at this school, and we should be discussing what we can do as ASLC. We would like to suggest that the focus of this meeting will be on creating the ad hoc committee mentioned in the email, and creating concrete goals and agendas.
 - B. Nicole: What happened at the emergency meeting?
 - C. Jacob: Would someone like to share or I can share my notes
 - D. Caroline: Some main points were:
 - 1. Proposing a bill to strike minutes
 - 2. Writing a letter to Elsa about resigning, but she did that on her own, so it's not necessary
 - 3. Making an ad hoc committee
 - E. Zoe: We discussed having an organization come in and verse Senate on antibias conversation
 - F. Caroline: the ad hoc committee could target creating safer spaces on campus, should be looked at outside of our space. We can talk about what we want to achieve with the committee
 - G. Jacob: possible objectives?
 - 1. Cas: Making ASLC more accessible/inclusive
 - 2. Quentin: Is it just inclusion within ASLC or LC community as a whole?
 - 3. Nicole: Since we represent students and because of the incident we should focus more on what the ASLC is doing?
 - 4. Alex: It feels like biting off a lot to focus on the entire community. A

- good starting point would be looking at ASLC
- 5. Frances: I don't think we should dismiss looking at the entire school, and could start with looking at the ASLC
- 6. Caroline: I think we should look at the student body, it's important and this incident shows how our voice reaches the entire school
- 7. Quentin: In Elections Committee we had a discussion about how

 Cabinet is largely white because most people who run for Senate are

 white. So we were talking about getting a more diverse pool of

 Candidates. How do we change how we reach out?
- 8. Roland: Focus on the ASLC office space because it's a physical space.

 Right now there are just Community Agreements and nothing else regulating what the office is used for. Make it more clear what happens in and out of the space
- 9. Lucia: We have Community Agreements but we could put some of them in the Constitution so we have to actually follow them. Then maybes there's repercussions if they're not upheld.
- 10. Quentin: Elizabeth I know your committee had a meeting, wondering what happened then
 - a) Had 1:1s then EIJ open meeting at 1
 - b) Number of committee members and senators talked about the importance of moving conversation towards systemic racism around campus, people had different opinions on what progress would look like but found compromises. Agreed on centering the voices of people were harmed. We made a list of task items people were going to bring to the emergency

meeting

- H. Roland: Clarifying question How do you create an ad hoc committee?
 - 1. Jacob: Two main routes
 - a) President can make one without a vote
 - b) Senate can vote on one, with a name everything else is up to you
 - Alex: I made one last year and it was easy and smooth, whoever
 makes it decides what they want to do with it. I told people who were
 interested in Textbook Subsidies to come talk to me. It's not super
 structured.
 - 3. Jacob: If there is one created, there is a portion in Senate that gives time for updates
 - 4. Quentin: anyone interested in chairing?
 - 5. Jacob: This could also be something you think of outside this space and create more solid goals and leadership. All up to you
- I. Cas: Who came up with this idea when writing the letter? If they had objectives?
 - 1. Nick: It was something I was already thinking about over the summer because there's issues within the institution. Envisioned a steering committee with ASLC, leaders of affinity groups, faculty, public. They would schedule meetings and discussions, but not voting body to keep it more open. There could then be subgroups that lead discussions around campus. Hopefully, each committee of Cabinet would access their own committees and how they deal with barriers and bring it up with the steering committee.

- Michelle: I like the idea of solid goals so things actually get
 accomplished. During the emergency meeting their was talk of equity
 training for all of ASLC. Look at financially available options for
 training and making it open to the school if possible.
- Public(Hannah): This sounds like what IME does. They put on events/training around every week. I haven't been to one in a long time, but they advertise them.
- 4. Michelle: Ok we could work with IME
- 5. Maca: Or even working with clubs and organizations that are working really hard on equity and inclusion.
- 6. Erin: Tori in Office of Equity and Inclusion did a really good job explaining these things and using reflective language. It will always be a hard topic to talk about, so we can use her as a resource.
- 7. Harold: I did reach out to Tori and Angela and they're both supportive of this process but couldn't be here tonight
- 8. Quentin: can I suggest outlined goals
 - a) Equity training for ASLC and public
 - b) Looking into Constitution and bylaws and recommend solutions to legislation
- 9. Alex: Another useful thing could be trying to hear directly from affinity groups. Not everyone at our school looks at our legislation, it's broader issues than that. So we could reach out the people who feel excluded.
- 10. Cas: Didn't you throw out periods of discussion
- 11. Alex: Yes times for public discussion

- 12. Nick: I just sent a document to all of you, with goals
- 13. Caroline: I think there should be an emphasis on making people feel safe on campus, and giving them power back
- 14. Elizabeth: I would encourage all of you to think about how you're asking people to come to you who were harmed. Show up to affinity group meetings and learn something. It might be uncomfortable, but there's already a barrier you're asking people to overcome to come to an ASLC meeting to talk about that barrier.
- 15. Public(Hannah): Are the anonymous tip lines still up? Can we remind people they still exist?
- 16. Nick: We have to figure out the key situation then can update you.

 The one online still works.
- 17. Alex: Maybe it would be helpful to send out a survey from Auditor about what do people know about ASLC, what can we improve on.

 Doesn't require people to come into our space
- 18. Frances: I think it's a good idea, but how many people will it reach?
- 19. Alex: I don't think it's the only thing we should do, but it's another avenue for people to reach us and be anonymous.
- 20. Public(Hannah): Combine survey with anonymous tip line.
- 21. Maca: We should also have these conversations within our clubs/orgs. and having face-to-face conversations and taking notes on ideas. Once we have that then we can create a committee. Like every Friday, tabling and asking these questions
- 22. Public: Speaking as a senior who has known about ASLC, for context I'm ISLC president, the only visibility senators get is when we vote for

- them. We want to know how they're representing students and senators should be more active in getting more feedback. There's a lot more work to be put in to make spaces a place of trust. There is active work to be put in to find who can advocate for me.
- 23. Quentin: Going back to committee, do what some goals and ideas outlined and create now, discuss more and create later?
- 24. Madeleine: Sounds like everyone is in favor of creating it. Might be beneficial to create it, then people invested in it can come together and outline goals
- 25. Maca: I think if we start with goals we'll engage with more people.

 We can create it but then its just there. We need to create the base of what we're going to work on first.
- 26. Madeleine: I think we should come up with concrete goals today then
- J. Committee on Systematic Barriers Goals
 - Caroline: Under training their should be something specific for white
 Senators about alliship, could be discussion based
 - 2. Maca: I don't agree with that, it separates the community and we all work together
 - 3. Erin: I understand you need to check your privilege, but you would get that in the general training
 - 4. Frances: could be included in the entire training so it's not us vs them
 - 5. Caroline: My initial thought was not adding more work for people of color
 - 6. Elizabeth: I recommend allyship training because it goes beyond race and is applicable to all identities represented here.

- 7. Madeleine: I think there needs to be a plan to go to actively go to other spaces, otherwise I don't think it will happen
- 8. Quentin: Under investigation of barriers could be specific activities like going to other meetings
 - a) Zoe: Going to other committees
 - b) Quentin: looking at documents
 - c) Alex: Wording of investigation is odd because it implies an end point, but we should continue to attend meetings and also sounds like we're going to investigate them
 - d) Lucia: use the word outreach for continued conversation
- 9. Cas: That could go under outreach along with tiplines
- 10. Roland: Revising the Community Agreements and coming up with consequences for violating
- 11. Quentin: outreach to go into communities and break down barriers
- 12. Minai: In IME we have mandatory workshops that are very beneficial
- 13. Public: We think outreach to other groups are relevant, but should be careful. IME is a great place that represents many communities and those without leaders. We've organized an open space for people to talk to us that you can take advantage of.
- 14. Maca: Focus on outreach to a more diverse pool of candidates
- 15. Alex: In Elections Committee we were talking about trying to understand why some people choose not to run, and telling people what can come out of running.
- 16. Elizabeth: the EIJ is working on this, we did outreach to all the affinity groups at the beginning of the year, but that was one meeting. We're

- going to hold a mixer where everyone invites 5 people they think are capable of being student leaders and advertising what's available and why they can do it
- 17. Alex: We will be having a special election in Spring where we can test these strategies
- 18. Lucia: I think an underlying issue is student engagement with ASLC.

 We can do all these things to keep senators reliable but a huge aspect is getting people to want to have a voice in ASLC.
- 19. Roland: Going off of that, would people be interested in having transparency be a goal of the committee, we don't want people to think of this after the fact
- 20. Quentin: I don't think this committee would be the best place for this.

 Maybe a subcommittee under CSRC.
- 21. Nick: I would encourage all of you to use your outreach fund
- 22. Alex: I wanted to remind everyone that we wanted to outline concrete goals. We can keep adding things or use this as our starting guideline.
- 23. Nicole: Maybe we could form branches off of these
- 24. Zoe: How would it work if there were subcommittees? Would they all meet together?
- 25. Jacob: Up to the membership
- 26. Roland: I don't think it would be beneficial to divide everything up. In getting involved, these are all things we should all be thinking about
- 27. Madeleine: This is how SEED runs things, they have separate meetings for different projects then a weekly meetings where they

- update on them all.
- 28. Alex: I like that idea because then we have a cohesive group meeting.

 I have a feeling this committee will be pretty large, so it might not be productive to have a lot of people meeting once a week.
- 29. Caroline: Some of these things all of us can do and don't need to be apart of the committee, it's about having better accountability
- 30. Quentin: do we want to figure out membership
- 31. Alex: is anyone opposed to creating the committee now
- 32. Maca: I don't think we're ready now, I want us to know exactly what we're doing more so that throwing ideas up on the board
- 33. Quentin: To a certain point we need focused goals, we'll need the committees to hammer down goals
- 34. Zoe: If we do subcommittees we already have that outline up there
- 35. Erin: how hard is it to create a committee?
- 36. Helen: I can just make it
- 37. Jacob: Do you all want to agree on a name
- 38. Michelle: something for the goals: acronym for goals can be PIO (Provide, Investigate, Outreach)
- 39. Quentin: Are we ok calling it Committee on Systemic Barriers
- 40. Roland: Would it be helpful to have a conversation on when we could meet and who's interested so it can't be pushed off
- 41. Nicole: What if designated time in Senate? Then it will be consistent and everyone has to show up
- 42. Frances: To hold everyone accountable, has to be before senate
- 43. Cas: Ad hoc get to say what's going on right? That could be the time

- C. William: I have hired an assistant. Finance Committee funded three grants, one was for the Meridian and improving quality, SEED for a beekeeping initiative, and Abdo for his late night show
- D. SOC: Funded garden club, next week we have two applications. Next week I have a meeting with Elizabeth about what equity looks like in budget application. Revising website. FSEC had a meeting about having RAs build links, rep from DSU solved an issue with people being able to skip the line if they have lower body strength issues. William, Elizabeth and I are looking into having a grants night to give students information
- E. MC: Had a comprehensive analysis of past elections and making them better and more equity focused. Next week will be sending out VP application. I'm in SAA, sunday morning will be a parents brunch at 11:30 so avoid that

- appropriate time to release it. Margaret Upton from the Health Center reached out to me/Helen about updates on STI testing on campus, that I will report back to you.
- H. Mikah: I'm missing about 6 of yours meet your Senators if you could send that. Goal for Pios for Pios is \$20,000 and we have homecoming this weekend. Working on putting anonymous tip lines in the dorms. If you have suggestions with advertising let me know. Katie is the vice chair if you also have ideas.
- I. Helen: Today was the first day of Board of Trustees. Today was Campus Life, Institutional Advancement, Finance Committee, and a dinner. There will be a survey that is super important and you should encourage people to take it. They are voting on a 4.75% increase in tuition, they know it sucks but it's necessary. There is an opening for Chief of Staff, been waiting to see if sending another email on racist incident. Monday there will be Executive Council if you have any questions we can bring up.
