

## Senate Bill Number FA20 SB001

### A Bill to Add Campus Activities Board to Constitution

---

Be it enacted by the Senate of the Associated Students of Lewis & Clark here assembled that:

**Section 1: Amend Article III, Section 1, Subsection a to read:**

- a. Shall include the following members: President, Vice President, Treasurer, SAAB Chair, CAB Chair, SOC Coordinator, EOC Coordinator, EIJC Chair, SRC Coordinator, Auditor, Chief Justice, and Director of Elections

**Section 2: Add Article III, Section 6 to:**

6. The Campus Activities Board Chair (hereafter: CAB Chair) shall oversee and facilitate all matters pertaining to the Campus Activities Board

- a. Shall oversee, organize, and chair the Campus Activities Board (hereafter: CAB),
- b. Shall serve as a voting member of the Cabinet, accorded one (1) vote
- c. Shall be elected by the student body upon receiving a plurality of the votes cast
- d. Must be a fully enrolled student at the College of Arts & Sciences with at least one (1) prior year of experience on the CAB to be eligible

**Section 3: Amend Article III, Section 14 to read:**

14. The ASLC Cabinet shall consist of ten (10) standing committees, charged with administering action within their purview and headed by a Cabinet member, which shall operate and conduct business in accordance with their respective bylaws unless otherwise stipulated within this Constitution, and shall be organized as follows

**Section 4: Add Article III, Section 14 subsection c:**

- c. Campus Activities Board
  - i. Shall be chaired and managed by the CAB Chair
  - ii. Shall be composed of four (4) members: one (1) Chair, one (1) Vice Chair, one (1) Director of Marketing, and one (1) Director of Administration
  - iii. Shall operate in accordance with CAB Bylaws
  - iv. Shall create, organize, and implement inclusive events for the students of Lewis & Clark and offer event consultation and support to individual students and student organizations

**Section 5: Amend Article IV, Section 3, subsection a to read:**

- a. Cabinet elections shall be held the 8<sup>th</sup> week of every Spring Semester
  - i. All students enrolled in the College of Arts and Sciences in good academic standing and meeting all stipulated requirements for each respective office shall be eligible to run for President, Vice President, Chief Justice, EOC Coordinator, SRC Coordinator, Treasurer, SOC Coordinator, SAAB Chair, CAB Chair, and EIJC Chair
