Finally, I hope work with Senators on establishing new financial resources and grant opportunities for students wishing to pursue unpaid internships and other unpaid career opportunities off-campus. We need to do more to support our student entrepreneurs and self-starters! ### **Report for Goal 1**

In my experience as a Senator this term, I believed that the Senate upheld the interests of the student body at times, but there is still room for improvement. ### **Report for Goal 2**

Fall 2020 showed how painfully wide the gap between student and admin is at LC, and ASLC plays a pivotal role in narrowing that gap. We did a great job of increasing our own influence on Executive Council members this term, but as representatives of the student body at large who prioritize equity and diverse views, we must ensure our constituents have that same ability.

### **Report for Goal 3**

Mikah did a great job at this during this term, laying groundwork for this type of collaboration to be further pursued. I share his belief that ASLC should continue looking at ways to collaborate with other student governments across the Oregon academic community. We must keep up the momentum and improve as a community of students next term.

### **Report for Goal 4**

I maintain my belief that all campus safety officers at Lewis & Clark should receive full, comprehensive trauma-informed training to be able to safely respond to mental health issues on campus. 2020 gave America a shocking mental health crisis, and college students are the hardest hit. I hope to collaborate with Senators and Representatives next term on this. Officers ought to receive the training from the College, not paying for it themselves out-of-pocket.

## **Report for Goal 5**

I hope to work with the Career Center and the Bates Center to expand grant opportunities for unpaid internships, which are one of the most morally-reprehensible forms of employment imaginable. It is in the best interest of ASLC and the student body that more opportunities be provided.
