Dear Lewis & Clark Students,

My name is Jessica Carron, and I oversee the Office of Student Rights and Responsibilities. As we launch into a new year, my hope is that we can continue to grow and learn as a community by being more knowledgeable about policies and how our day-to-day actions may have an impact on those around us. As such, I may periodically pop into The Bark to provide you updates around policies, community concerns, and opportunities to support our community accountability efforts.

For today, I have two topics I wanted to bring awareness to:

- 1. Concerns from our neighbors: The neighborhood around Lewis & Clark has raised concerns about student activities around the entry gates and onto the streets west of campus. We are working with these neighbors to ensure students who may be causing disruption are properly addressed. Please be aware that the college's Code of Conduct applies to students at all times, whether on or off-campus. Additionally, I hope we can all reflect on the fact that our neighbors, while not a direct part of our college, are a part of our community. Please treat them with the same respect and care that you would expect in return.
- 2. Adjudication clarification for COVID-19 and other policies: This summer, our office received an inquiry about how we plan to enforce COVID-19 and other policies. There were some concerns raised about the COVID-19 Pledge and that students may be automatically removed from campus for violating COVID-19 policies. While the college takes the health and safety of our community seriously, particularly in light of COVID-19, please be aware that all students have the right to due process through the Code of Conduct. That means you have a right to a fair hearing and a thoughtful outcome that takes into account the context of the violation, the severity of the violation, and your history of behavior. We do not remove students from campus without due process, unless we are taking interim actions to ensure the safety and well-being of the Lewis & Clark community. Even with these rare interim actions, you would still be guaranteed the right to a hearing. To know what is expected of you, please review the COVID-19 Mitigation Policy.
